#### **Financial Updates**

- The Board received good news in regards to the Division's financial status for the year ending August 31, 2019. Despite a projected deficit, hard work and strategic efficiency planning resulted in an overall small surplus by the end of last year.
- Unfortunately, due to an unexpected increase in over \$1 million in insurance premiums (274 per cent) as well as an additional \$2 million loss in provincial grants, the Board expects an approximate \$3 million deficit for the 2019/2020 school year. Further efficiencies and adjustment of service levels are presently being investigated in anticipation of the next provincial budget announcement in February 2020.

#### **Policy Updates**

As part of their regular review, Trustees received recommended changes to Policies 1, 2, 5, and 6 from the Policy Committee. Proposed amendments are to align with current government legislation, and the new Education Act, as well as to clarify intent of each policy. Policy 2, Policy 2 - Appendix C, and Policy 6, each require further consultation before approval. Approved changes to Policy 1, Policy 2 - Appendix A and Appendix B, Policy 5 and Policy 7 are on the Division's website.

#### Student Learning Updates: Literacy and Exam Results

- Various literacy initiatives have resulted in significant student improved results over the last year.
- Superintendent Lewis was pleased to share the significant growth in the Division's 2018/2019 PATs and Diploma Exam results.

#### **School Councils' Annual Reports**
