- Reported on the Saskatchewan's Court of Appeal has upheld provincial funding for non-Catholic students in Catholic schools, reversing a lowercourt decision that pushed the government to consider a seldom-used constitutional escape hatch. The unanimous decision means the government will not have to invoke the notwithstanding clause, as it had promised to do. That could change if public school divisions appeal to the Supreme Court of Canada, though there is so far no clear plan to do so.
