#### Steps

1. Check to see if the application/platform you are wanting to use is already in the GYPSPD Privacy Impact Assessments list.
2. If not, work through this checklist by checking both the Privacy Policy and Terms of Use documents.
3. Show your findings with your principal. As per AP140, your principal has the responsibility to effectively manage and utilize digital resources.
4. If your principal approves the application/platform to be used in your building, submit this form.  
If your principal does not approve the application/platform, do not continue with this form.
5. Submit a Service Desk ticket with the title "PIA Request - (name of application/platform goes here)" and indicate in the description of the ticket that you have submitted a GYPSPD PIA School-Level Checklist.
